INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2020 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2021 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

¹The term “state” is used to refer to all the states and territories required to comply with Synar as part of the Substance Abuse Prevention and Treatment Block Grant Program requirements (42 U.S.C. 300x-64 and 45 C.F.R. 96.121).

Where and when to submit the Synar report

The ASR must be received by SAMHSA no later than December 31, 2020 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2021 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of *SSES Tables 1–8* (in Excel) to WebBGAS. **Please note that, beginning with the FFY 2021 ASR, SSES will generate Tables 6, 7, and 8, which are based on the optional microdata on product type, retail outlet type, and whether identification was requested. If your state does not submit these optional data, Tables 6, 7, and 8 will be blank. Merchant education and/or training

Working with local Community Service Boards and their coalitions, we had planned that every tobacco retailer in Virginia would receive merchant education between July 2018 and June 2020 with priority given to those who have had a violation in the last year as well as those within 1000 feet of schools or parks. However, because of COVID-19, all merchant education was put on hold in March for the health and safety of our prevention workforce and their communities.

Store Mapper continues to be updated regularly to reflect the changing retail landscape with newly opened stores being added and recently closed stores being deleted thus keeping our list of tobacco retailers current.

Point of Sale Toolkit (POST) - In collaboration with the 40 Community Service Boards and their coalitions, we had planned that every tobacco retailer would have a store audit conducted between July 2018 and June 2020. Audits consist of looking at products, pricing, promotions, and marketing in the store and at the point of sale. This information will inform communities and the state about the current retail practices to help shape future policies. This plan was interrupted because of COVID-19 and all audits were put on hold in March 2020. Another round of inspections will be conducted between July 2020 and June 2022.

Our relationship with the Attorney General's Tobacco Regulation and Enforcement Office continues to be strong. Community Service Boards continue to look for violations of any signed Agreements of Voluntary Compliance (AVCs) while conducting Store Audits. Any violations found are being reported back to the Attorney General's Office for enforcement.

Even though we were not able to complete Synar inspections this year, our concern over last year's high RVR remains. We have been working with Virginia Alcoholic Beverage Control Authority (ABC) to conduct additional compliance checks outside of the Synar sample. We had agree that 1000 additional checks would be completed this calendar year but those efforts were halted due to COVID-19. We continue to leverage higher level officials to address the issue from an interagency perspective in hopes of increasing resources for law enforcement and inspections. ABC will continue to conduct the inspections under the contract with DBHDS and no changes in inspection protocol are planned.

Va DBHDS has developed strong partners in ABC and VDH. Instituting a formal contractual relationship with ABC has assured that inspections occur in a timely fashion.

Last year's legislative efforts, which included clean up of 2019's T21 bill, retail licensing, and a flavor ban were continued until 2020. This year, VDH, American Heart, American Lung, and American Cancer Associations, with support from some legislators, will be putting in legislation to establish retail licensing. Included in this bill are licensing fees, the removal of PUP fines, an increase in retailer fines, and required merchant education and enforcement.

3. Describe any challenges the state faces in complying with the Synar regulation. (Check all that apply and describe each challenge in the text box below it.)

Limited resources for law enforcement of youth access laws

With the loss of the FDA contract, Virginia went from inspecting roughly 50% of our retailers annually, to 8%. We believe the severe drop in enforcement is what has led to an increase in our RVR. We receive no state money to address this issue.

Limited resources for activities to support enforcement and compliance with youth tobacco access laws

Although we were unable to conduct inspections this year due to COVID-19, list accuracy remains something that can be improved. Communication was sent to all law enforcement agents prior to COVID regarding protocol and highlighting some inconsistencies – i.e. marking vape shops as not selling the product rather conducting the inspection. We plan to conduct a training for all ABC agents involved in Synar in the spring to ensure that they are all aware of the protocol.

COVID-19 was/has been the biggest challenge of this inspection year. We rely on Virginia Alcoholic Beverage Control Authority (ABC) to conduct our Synar inspections. Unfortunately, under the guidance of the Department of Labor and Industry Safety and Health Codes Board, they have not been permitted to conduct enforcement activities of any kind. I contacted them on a monthly basis beginning in May 2020 to see if there were any changes to this to which there were not. I have included the emails for your reference. I have also included a letter from ABC from October stating as such.

Agents are all assigned a certain number of checks that must be completed. All agents receive extensive training in all facets of law enforcement and specific training on the execution of a UAB operation.

C. Underage Buyer (UAB) Recruitment and Hiring - Underage buyers should be recruited based on the following criteria:

1. The Regional Special Agent in Charge is responsible for ensuring the efficient and appropriate recruitment and hiring of UABs. Regions should employ UABs who represent diverse demographics.
2. Age Requirements
 - a. Alcohol - Underage buyers used for alcohol compliance checks shall be 17, 18, or 19 years of age at the time of an operation.
 - b. Tobacco - Underage buyers used for tobacco compliance checks shall be 16-17 years of age at the time of an operation.

3. UABs should be youthful in appearance and shall not appear older than their true age.

4. Underage buyers must possess a valid Virginia DMV issued Driver's License or Virginia DMV issued identification card.

5. Application process:

a. UAB applicants shall submit a criminal history check consent form and photographs as the first step of the application process. These forms may be collected by the recruiting agent or supervisor and forwarded to the Regional SAC.

b. UAB applicant photographs must accurately depict the way the UAB would appear during an operation. Applicants must be clean shaven and not wearing makeup or jewelry in the application photographs.

The application photographs must be taken in adequate lighting with a plain background. Applicant photographs must include a close facial photograph and a full body photograph.

c. If the Regional SAC recommends that the applicant advance in the application process after reviewing the application photographs, the consent form and photographs will be scanned and emailed to the Chief's Administrative Staff Assistant.

d. The Chief's Administrative Staff Assistant will present the application photographs to the Deputy Chief of Operations for approval.

e. If approved by the Deputy Chief of Operations, the Chief's Administrative Staff Assistant will complete the criminal history check.

f. The Chief's Administrative Staff Assistant will notify the Regional SAC of the approval and results of the criminal history check.

g. If the applicant is to proceed in the hiring process, the Regional SAC will ensure that the UAB Hiring Manual is followed to complete the hiring process.

h. The recruiting agent shall ensure a clear digital photograph of the UAB is taken and attached with the application.

6. UABs cannot be hired as a means to avoid prosecution, judicial findings, or other penalties.

7. UABs are required to have a bank account to comply with direct deposit requirements.
