Young Adult Survey Community Forum Recap

Thank you to everyone who attended the first CSB Community Forum of 2022! Our topic was the Virginia Young Adult Survey (YAS). It was fantastic to see you all there and we agree: so far it has been the best forum of the year!

Here is a quick recap of the forum, which was facilitated by Cheryl Winston and Ivonne Parra from OMNI:



- The YAS is a 15-minute anonymous survey for 18-25 year-olds about substance use and mental health behaviors and opinions. The survey will help fill data gaps, facilitate efficient prevention activities, and monitor important trends.
- We took a pulse of familiarity with the Young Adult Survey; over half of attendees were familiar and/or implemented the YAS in the past. Together we identified common recruitment methods, and barriers for implementation. The survey will be available in 4 languages!
- Shannon Urum of Northwestern and Brenna Link of Danville-Pittsylvania CSBs shared implementation tips based on their previous experience with the YAS.
- Finally, attendees shared great suggestions in our large group discussion about recruitment, incentives, and partnerships in order to make your YAS implementation a success.



Ensuring your Needs Assessment Responses are'Complete'

Many CSBs are finding that even though they submitted all their environmental scan worksheet information to our online questionnaire, there are missing entries in their totals and some are listed as "incomplete."

One reason this frequently happens is that the last step to finalize the submission of each entry is missed. After you enter all your data, you will be shown a screen with a summary of your answers asking you to double-check to make sure they are correct and confirm. After you have reviewed your responses, DO NOT exit the window by closing your tab or browser. Instead, scroll to the very bottom of the page and CLICK THE FINAL NEXT BUTTON on the lower right to confirm your answers are correct. (see picture below)

The next screen will then thank you for completing the questionnaire. When you see this final "Thank You screen" you can be confident that your data has submitted properly (see picture below) Then you can exit your browser or tab.



Ensuring each survey response is complete helps in a couple of ways:

- Faster and more accurate reporting to CSBs how much of the Needs Assessment you've completed
- Easier analysis for OMNI due to less work filtering through "incomplete" responses

ASAC Connection Time with ASAC Coalition member Lori Gates-Addison of Cumberland Mountain hosted an online Facebook discussion on the impact of Adverse Childhood Experiences and Trauma in communities.
