Coalition Readiness & Effectiveness Assessment Due in BG FY22-23

This is a reminder that OBHW requires all CSBs leading coalitions to conduct the Coalition Readiness & Effectiveness Assessment at least every two years. Research shows that effective coalitions are more likely to retain members, sustain efforts, and impact projected outcomes. In your logic model, you will see a related short-term outcome in the Coalition section: *Each BG-supported coalition will have 75% of coalition members participate in the Coalition Readiness & Effectiveness Assessment in FY 2022-23.*

Most CSBs conducted their first assessment in Year 1 of the current Block Grant funding period (FY20-21). That means **most of you will need to conduct it again this fiscal year, before the end of June 2023.**

As we do so, we remind everyone that the codebook to interpret the Excel data file is in the [ACEs Tools folder](#). In the codebook, use the labels in red to interpret the columns and values in your data file. This process is important to ensure the evaluation data is as accurate as possible.
