

End of Year Wrap Up!

It's that time again! The end of the Block Grant fiscal year (FY) is steadily approaching. Here are a couple things to keep in mind as we near <u>June 30th</u>:

- 1. **Data entry reminder** All Block-Grant-funded activity data must be entered in PBPS byJuly 14th, and all rejected activities must be addressed/corrected by July 31st. This includes Block Grant & SOR dual-funded strategies.
- New campaigns and cohorts Please let the OMNI TA Team know ASAP if your CSB needs to add any new campaigns or cohorts to PBPS/your CSB's Data Entry Plan for this FY. This will ensure all of your CSB's campaigns and cohorts are carried over into the template we are creating for FY23-24's evaluation roadmap.
- 3. Evaluation Planning Prep Survey Please remember to complete the <u>Evaluation Planning Prep</u> <u>Survey</u> we sent out earlier this month. We ask that at least one member from each CSB complete the survey by Wednesday, May 31st.
- 4. **Coalition Readiness & Effectiveness Survey Period** CSBs can survey through June 30 and there will be no reporting until after the BG Fiscal Year ends (June 30).

Thank you for consistently showing up and working hard to serve your communities. We're excited to wrap up this fiscal year and continue making an impact together in FY23-24!

Community Spotlight! Alleghany Highlands Increases Community REVIVE Trainings Offered

Alleghany Highlands Community Services is excited to be implementing monthly community REVIVE trainings, thanks to the addition of three new staff members. Participants trained receive naloxone on the spot when they complete the training.

The training pictured above was held at Boys Home, a program that provides emotional support, guidance, on-campus schooling, spiritual care, and vocational or technical training for young men from ages 6 to 17. Boys Home Director of Education, Theresa Johnson, reached out to Prevention Services at Alleghany Highlands Community Services to facilitate the training for their staff members. Another training for residential house parents--who provide education and guidance on-site--will be held later in the month of May.

Congratulations on preparing more community members to administer naloxone and ensuring they have immediate access to it to put those skills to use!


